The following matters will be heard and/or acted upon:

Appeal No. 2019-7 filed by Carlo M. DiPersio, Ursula Price and Richard Harris, seeking annulment of the Sandwich Town Committee's decision to grant to Heritage Plantation of Sandwich, Inc. Certificates of Appropriateness in Application No. 19-127RB for the demolition of an existing 30' yurt and deck and replacement with a new 24' yurt with smaller deck; and Application No. 19-128 for the relocation of several elements of challenge course to be further away from Shawme Road all to be located at 0 Shawme Road and 0 Pocasset Road identified on Town Map 37 as Lots 1 & 2. Harris seeking reversal of the Yarmouth Town Committee's decision to grant to Des Gallacher, Caroline Gallacher, and Mary McNally a Certificate of Appropriateness for a new residential building to be located at 16 Pine Street, Yarmouth Port, Massachusetts and identified as Town Map 123, Parcel 141. The Yarmouth Town Committee's decision was filed with the Yarmouth Town Clerk on Wednesday, September 11, 2019. The Appeal Petition was filed with the Regional Commission on Friday, September 20, 2019, and a copy is available for public viewing at the Yarmouth Town Clerk's Office, 1146 Route 28, South Yarmouth, Massachusetts, during regular business hours.
