MINUTES

Minutes of a public meeting held on January 4, 2023, 6:30 pm at the Sandhill School, 16 Dewey Ave Sandwich, MA.

1. **Meiggs Backus Property Conservation Restrictions-** Notarized Signing update by staff. (JW) CR was not notarized. DNR is waiting for new version from KP Law which the Commission will eventually sign.

2. CONTINUED HEARINGS

a. **DEP File No. SE66-1969 Jane Petrozzino c/o Hamlyn Consulting** has filed a Notice of Intent for proposed sand nourishment and stair repair to include the installation of helical piles at Map 85 – Parcel 26, located at **64A Salt Marsh Road.** No representative present. Lynne Hamlyn submitted letter to Commission dated January 4, 2023 which was read by chair. During discussion Commission reiterates that it does not want any machinery on dune. A motion was made to close and approve with standard and special conditions as discussed (LPW). Second (ED). The motion was passed with a vote of 4-0-0.

3. ENFORCEMENT

a. **Brady's Island** – Staff updates on unauthorized cutting w/in 50 ft. buffer. (JW) The Sandwich Tree and Landscape Advisory Committee cut a significant amount of vegetation within the 50 foot buffer zone, getting almost to the resource area. Heavy cutting within a buffer zone is an egregious violation. Photographs of the cutting was shared. It's the department's recommendation that the Tree and Landscape Committee be barred from any further work activity on the property. The Committee can still visit and enjoy the property. A Stop Work Order to the Tree and Landscape Advisory Committee was read. (KW) wanted to know what remedies could help going forward. (JW) states waiting for the vegetation to grow back will be a solution to the issue. Recommendation is prohibit work to be done in that area going forward. A motion to adopt the enforcement letter and recommendation (LPW). Second (ED). The motion was passed with a vote of 4-0-0.

4. REQUEST FOR EXTENSION

a. Original Filing **DEP File No. SE66-1802 Sean Cashell c/o Prime Engineering, Inc.** has filed a Notice of Intent for dune replacement via coir envelope installation, sand nourishment and stair/deck repair at Assessor's Map 85 – Parcel 14 located at **90 Salt Marsh Road, East Sandwich, MA.** A motion was made to approve a 3-year extension (LPW). Second (ED). The motion was passed with a vote of 4-0-0.
