Sticker Eligibility Rules:

1) Vehicles with commercial license plates or a business or commercial enterprise located in Sandwich must possess a Commercial Sticker in order to use the Transfer Station.

Commercial stickers are required for disposal of commercial waste at the Transfer Station. Commercial waste stickers can only be purchased by a resident or non-resident owner of a business or commercial enterprise located in Sandwich. Commercial waste will be defined as all non-hazardous waste generated by a business or commercial enterprise located in Sandwich. All waste must have been generated in Sandwich. Commercial waste includes refuse created following landscaping or services performed in exchange for payment on a residential property, provided the individual undertaking the work is not the homeowner.

If the commercial waste created derives from one or more of the following processes, a Commercial Transfer Station Sticker is required:

- Waste from rented properties collected by a landlord, their letting agent or trash contractor.
- Waste collected from a residential property by a commercial organization in exchange for payment.
- Waste from a residential property brought to the Transfer Station by anyone other than the sticker holder(s) of the household.
- Waste from home-based business activities such as accountancy, consulting, day care, hairdressing, etc.

2) Transfer Station stickers are Town property. Any violation of Transfer Station rules may result in loss of sticker.

3) Town trash bags are required to dispose trash. Bag fees are subject to change without notice.

4) Once issued, Transfer Station Stickers are non-refundable.

5) For vehicles paying Excise Tax (tax on your car) in Sandwich, no further information is needed

6) For vehicles not paying Excise Tax in Sandwich the following information will be needed to purchase a sticker - **Documents must match Applicant's name and address.**

- Copy of vehicle registration
- Current Town of Sandwich real estate tax bill
(Tax bills can be verified by Tax Collector's Office. No copy needed)
- Copy of 12 month lease agreement with Sandwich address
- Copy of trust documents for Town of Sandwich property showing trustee name matching vehicle registration
- Business card for business vehicles along with authorization letter on company letterhead
- Lease agreement for leased vehicles

Replacement stickers are \$5.00 if original sticker is not returned.
